Action to be taken to contain the spread of Coronavirus (COVID-19) by Subject: the Department -reg.

The Secretary (Coordination), Cabinet Secretariat had held a video conference with all the Ministries/Departments on 17.03.2020 in order to discuss the actions to be taken against the spread on Coronavirus (COVID-19).

- 2. Following are the major decisions taken during the meeting:
 - (i) Implement instructions issued on the subject by Cabinet Secretariat, Health Ministry and DoPT strictly (relevant instructions enclosed).
 - (ii) Video conferencing may be held with the sub-ordinate offices to sensitize and also assess the action taken.
 - Avoid non-essential travel within the country and within the city. (iii)
 - (iv) Postpone scheduled meetings to avoid gatherings
 - (v) Ensure social distancing – meaning avoid groupings
 - (vi) Sensitize employees to protect themselves and also spread the message around them.
 - (vii) Avoid lifts as much as possible.
 - (viii) Ensure hand hygiene practices - washing with soap is as effective as hand sanitizer.
 - Contamination due to droplets and dirty surfaces may be avoided. (ix)
 - (x) Avoid visitors wherever possible.
 - Maintain distance between two individuals. (xi)
 - Closedown schools (xii)
 - (xiii) User thermal scanning
 - (xiv) All discussions and conference be either through telephonic/Emails/e-Office or video conferencing (It was suggested to avoid any kind of face to face group meetings).

- (xv) Any official who reports sick due to any reason should be sanctioned immediate medical leave.
- (xvi) A specialist who reported with the Secretary (Coordination), Cabinet Secretariat from ICMR suggested all the officers to go through the website www.worldometers.info/coronavirus for more authentic information.
- 3. In this regard, the Secretary, DEPwD shall hold a video conference with all the Statutory Bodies, CPSEs and NIs/CRCs on 19.03.20 at 11 am.
- 4. All the concerned reporting officers are required to participate in this video conference.
