Minutes of the Meeting of the Screening Committee for scrutinizing the applications received for the post of Director, National Institute for Empowerment of Persons with Multiple Disabilities (NIEPMD), Chennai.

The post of Director of NIEPMD was filled up on deputation basis for a period of 3 years. Accordingly, the tenure of present incumbent was expired on 13.03.2015. With the approval of the Hon'ble Minister (SJ&E) the tenure has been extended for a period of 3 months (i.e upto 13.06.2015) on the same terms & conditions or until the new Director is appointed, whichever is earlier.

2. As per the Recruitment Rules for the post of Director, NIEPMD educational qualification and other qualifications is as under:-

(c) Ten years experience in the field of rehabilitation of persons with multiple disabilities out of which at least 5 years should be at a senior post in the area of research/teaching in a training institute.

II) Desirable Qualification:

- (a) Ph.D with specialization in Cerebral Palsy Autism/Deaf-Blind/Multiple Disabilities with publications in reputed journals.
- (b) Management of an institution for the persons with multiple disabilities.
- 3. The advertisement inviting applications from the eligible candidates for the post of Director, NIEPMD was published in various national news papers and employment news dated 4-10 April, 2015. The advertisement also uploaded on website on the Ministry and Institute. The applications were invited within 30 days from the date of publication (i.e. last date of application received was 03.05.2015). In response of the advertisement 15 applications were received. The applications of Shri B.B. Samaddar, Prof. Dr. C.M. Tom Manohar and Shri Suhas Rangarao Kale were received after last date i.e 05.05.15 & 20.05.2015 respectively.
