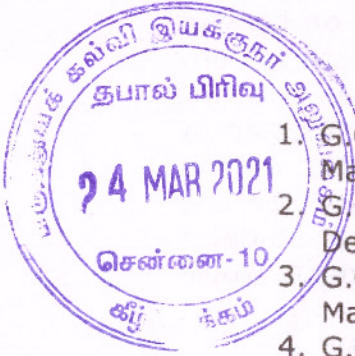
ORDER

Whereas on considering the recommendations of the expert team of the Doctors and Public Health Specialists and based on the directive of Government of India, Ministry of Home Affairs, State-wide lockdown was extended from time to time and lastly extended till 24.00 hours of 31.03.2021 under the Disaster Management Act, 2005 in G.O.(Ms). No. 318, Revenue and Disaster Management Department, dated 28.02.2021.

4. In case of any ongoing examinations / practical examinations and those involving external examiners has already being scheduled and being conducted by any of these institutions those may be completed by

31.03.2021 without cancellation by strictly following the Corona appropriate behavior and Standard Operating Procedures. The Hostels for the Final Year students under all Under Graduate Courses / CRRI / Post Graduate Students would continue to function.
