

**Proceeding Providing Canteen Services at NIEPMD Campus**

1. M/s. Sri Vels Tiffin, Chennai
2. M/s. Sai Catering Services, Chennai
3. M/s. Rupan Raj Caterers (RR caterers), Chennai
4. M/s. Hanu Catering Services, Chennai
5. M/s. WEITUO Consulting Cloud Pvt. Ltd, Chennai

On evaluation the technical bids submitted by bidders following agencies qualified technically:

- (a) M/s. Sri Vels Tiffin, Chennai
- (b) M/s. Sai Catering Services, Chennai
- (c) M/s. Rupan Raj Caterers (RR caterers), Chennai

However, bids of following 02 (Two) agencies could not accepted by the committee for the reasons given below: -

- (d) **M/s. Hanu Catering Services** – FSSAI license applying application attached with bid. The application is in 3<sup>rd</sup> stage (Inspection stage), Bank solvency certificate not attached. Hence Not qualified technically.
- (e) **M/s. WEITUO Consulting Cloud Pvt. Ltd.** – At the time submission of bid document the bidder submitted one letter on company letter head regarding short fall of document and ask permission for one day to submit the short fall document, but even after passing of 21 days from Technical bid opening, no short fall document submitted by the bidder. Bidder not attached the solvency certificate. Satisfactory certificate from the agencies whose work order attached not attached with bid document. Certain work order attached neither signed manually nor digitally. Hence Not qualified technically. (Copy of letter submitted attached with proceeding)

In view of the above, it is brought to notice of all qualified bidder that price bid opening has been scheduled on “31<sup>st</sup> March 2023” at 03.00 PM at NIEPMD, ECR, Muttukadu, Kovalam (Post), Chennai – 603112. All qualified bidders are requested to attend the “Price Bid Opening Meeting” as per schedule.
