## Proceeding Providing Canteen Services at NIEPMD Campus

Based on NIEPMD tender notice No. NIEPMD/Pur4 (33)/2023-24 & CPP portal Tender ID No. 2023\_NIEPM\_719217\_1 for hiring of Canteen services, the canteen committee meets on 01<sup>st</sup> Aug 2023 to carry out the technical evaluation of bids received from the following agencies:

1. M/s. Sri Vels Tiffin, Chennai
2. M/s. Sai Catering Services, Chennai
3. M/s. Hanu Catering Services, Chennai

On evaluation the technical bids submitted by bidders following agencies qualified technically:

- (a) M/s. Sri Vels Tiffin, Chennai
- (b) M/s. Sai Catering Services, Chennai

However, bids of M/S Hanu Catering Services Chennai could not be accepted by the committee for the reasons given below: -

(c) **M/s. Hanu Catering Services** -

- (a) Required experience as per tender document not available.
- (b) The agency attached the work satisfactory certificate from M/S HCL Technologies since Dec 2022 for serving only 65 Members. No work order from M/S HCL Infosystems produced by the bidder.
- (c) The agency FSSAI registration date is 14<sup>th</sup> mar 2023, however HCL letter showing date Dec 2022 is contradictory as the FSSAI was implemented in the year of 2008, and it was mandatory for all vendors in business should register with FSSAI.
- (d) As per clause 2.3 of tender document the bidder should have running/ongoing contract of hostel mess or canteen for a capacity of 200 nos. appx. Could not be fulfilled.

Based on technical evaluation, the price bid of qualified bidders will be opened on 11<sup>th</sup> Aug 2023 (Friday) at 16:30 Hrs. Bidders may attend the price bid opening meeting if wish so, however in case bidders not present in the meeting, the price bids will be opened by the committee.
