As per the conditions of the subject tender notices, the Opening of tender documents received for the subject works was held at the Committee Room, NIEPMD on 14.7.2016 from 03.30 pm onwards.

Tender documents which were received upto 03.00 pm on 14.7.2016 in a sealed tender box were collected and opened by the duly constituted committee (vide Ref 3) in the presence of 08 (eight) bidders who had participated in the entire proceedings of opening of tender documents.

The list of bidders and the officials participated in the tender opening is enclosed as Annexure I & II respectively.

The Committee noted that total 20 (twenty) bidders from various places viz., Chennai, Coimbatore, Delhi, Madurai, Trichy, Bangalore etc., had submitted their sealed bids before the last date and time to receive the bids.

The committee in the presence of the bidders segregated the tenders for the said services viz., Manpower for NIEPMD HQrs and Manpower for NBER Exam cell and found that 13 tenders were received for Manpower for HQrs NIEPMD and 07 tenders were received for NBER Exam Cell (total 20 tenders)


