National Institute for Empowerment of Persons with Multiple Disabilities (NIEPMD) is a Central Autonomous Body under the Department for Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice & Empowerment, Government of India. The Institute intends to purchase Treadmill with unweighing system for its campus at Muttukadu. Kovalam, Chennai -603112, Tamilnadu (India).

The institute inviting e-tenders for procurement of <u>Treadmill with unweighing</u> <u>system</u>. The specification of Treadmill tendered are attached as appendix "A" to this tender notice. Interested bidders may submit their bids through NIC e-procurement portal as per date and time mentioned above.

INSTRUCTIONS TO TENDERERS

1.0 GENERAL TERMS

- (a) Tender will be available on NIC e-procurement portal URL "http://eprocure.gov.in/eprocure/app" from 17-05-2018, 09.00AM to 09-06-2018, 06.00PM.
- (b) EMD amount of Rs. 20,000/- & Tender fee of Rs. 1,000/- (non-refundable) should be paid online through NEFT or RTGS in NIEPMD account and payment receipt to be uploaded with tender document. Bids without Tender Fee and EMD amount or lesser amount shall not be considered for further evaluation No further correspondence will be accepted on the subject.
- (c) Units registered with National Small Industries Corporation (NSIC), Small Scale Industrial (SSI), are exempted from payment of EMD for the item tendered and subject to registration certificate being valid as on date of quotation.

Technical Bid is accompanied by a photocopy of valid NSIC/SSI Registration Certificate / Review Certificate.

- (d) Photocopy of application for registration as NSIC/SSI or for renewal of NSIC/SSI will not be acceptable. Such offers will be treated as offers received without EMD. No further correspondence will be accepted on the subject.
- (e) Registration with DGS&D will also entitle the Tenderer to claim exemption from payment of EMD.
- (f) However no firm is exempted for paying tender fees, irrespective of any category bidders have to pay the nonrefundable tender fees Rs. 1000/- for consideration of their bids.
- (g) No alteration or amendments shall be allowed after submission and opening of the tenders.
- (h) In case of any dispute arising with regards to this tender or its conclusion, the decision of the Director NIEPMD shall be final.

Interested bidder may submit their quotes by giving all the necessary documents in English or Hindi as specified. No manual bids will be entertained under any circumstances.

- 9.0 If the Equipments remains down beyond 48 hours, the firm will be required to provide a stand-by of the same or higher configuration, failing which the Director, NIEPMD Chennai will arrange for the Equipments on rental basis at the rate decided by the Director, NIEPMD, Chennai, which shall be final and binding, and the cost thereof shall be adjusted against the Security Deposit/Bank Guarantee.
- 10.0 Warranty period begins from the date of satisfactory installation and commissioning at location certified by Officers of NIEPMD.

- 11.0 The supplier has to provide training on operation of Treadmill to the officials of NIEPMD. In addition to above, vendor would also provide onsite training to end-user at the time of installation of equipment.
- 12.0 Any disputes arising out of this tender will be under the Jurisdiction of Court of Chennai only.
- 13.0 The total cost quoted should be exclusive of taxes. Applicable taxes to be mentioned separately. Tax applicable at the time of invoice will be paid.
