6. SPECIAL TERMS AND CONDITIONS

- 1. Bidder may visit the site of installation & Commissioning before quoting.
- 2. Requirement quoted above is approximate; it can be changed as per actual requirements (may increase/decrees).
- 3. Rate should include charges for removal of debris out of premises, removing stains, cleaning the site thoroughly and restoring it to original condition where work is undertaken.
- 4. Quoted rate should be workable and should include all overheads and profits.
- 5. Rate should include all taxes, duties, octopi, levies, Payment of wages as per Act, VAT etc. and should be firm for the entire contract period. No variation of rates will be allowed.
- 6. All components of the conference mic system supplied should confirm to the stipulations as in the relevant I.S. codes (Latest Edition) BIS specification shall be followed as applicable and should be UL certified. However, in the absence of the same the decision of Director NIEPMD will be final.
- 7. The tender is being called as an item rate tender to be quoted against the Bill of Quantity. However, all other materials as may be necessary for the satisfactory work completion are to be provided at no additional cost as deemed to have been covered under the scope of work/contract.
- 8. All civil, electrical, carpentry work will be done by the contractor and this cost also to be included in the amount quoted.
- 9. No advance payment will be made by the NIEPMD in any case.
- 11. Any discrepancy in settlement of bills may be brought to the notice of the NIEPMD within a period of one month after the settlement of the Bills. The NIEPMD will not entertain any claim regarding any dispute in settlement of the bills after the stipulated period.
- 10. The Contractor shall observe all the safety precautions for the safety of the labour and the employees of the NIEPMD during execution of works. He would be responsible for the safety of persons, employed by him.
- 11. The contractor shall be responsible for injury to persons or things and for damages to the property which may arise from omission or neglect of the contractor or their employees, whether such injury or damages arises from

carelessness, accident or any other cause whatsoever, in any way connected with carrying out of the work.

- 12. All the conditions of the contract shall be binding on the Contractor.
- 13. The Contractor shall comply with all the applicable Acts, Rules, Regulations, requirement of Law (s) for entering into contract and the NIEPMD will not in any way be liable or responsible for any default/irregularities/penalties on the contractors part.
- 14. The contractor shall comply with the provisions of Contract, Labour Regulation& Abolition Act, 1970, Minimum Wages Act and all other labour laws and other Statutory Regulations (both Central and States) that may be enforced from time to time by the appropriate authorities. The NIEPMD shall not be held responsible for any penalty on account of failure to adhere to the above labour regulations, etc. The contractor should be responsible to fulfill all the obligations in connection with the workers employed by the contractor for the purpose of the contract and all the Statutory and other liabilities if any including minimum wages, leave salary, uniform, ex-gratia, gratuity, ESI, Provident Fund, Workman Compensation, if any, etc. in connection therewith shall be on the contractor account and payable by the concerned contractor.
- 15. The contractor should obtain necessary permission that may be required for the purpose of this contract from such authorities as may be prescribed by law from time to time.
- 16. The contractor shall be fully responsible and shall compensate the NIEPMD in the event of any damage to men or material, injury/damage or death as the case may be, caused directly or indirectly due to the negligence of the contractor or his agents and / or his employees or workmen.
- 17. The contractor should not employ any person who is prohibited by law from being employed for fulfilling obligations under this contract.
- 18. Any act of indiscipline / misconduct/ theft/ pilferage on the part of any employee engaged by the contractor resulting in any loss to the NIEPMD in kind or cash will be viewed seriously and the NIEPMD will have the right to levy damages or fine and / or even terminate the contract forthwith.
- 19. In case of any default or failure on your part to comply with all/ anyone of the terms/ conditions, the NIEPMD reserves to itself the right to take necessary

steps to remedy the situation including, inter-alia, the deduction of appropriate amounts from dues otherwise payable to you and/or by taking recourse to appropriate recovery proceedings.

- 20. The contractor should not at any time do, cause or permit any nuisance on the site/do anything which shall cause unnecessary disturbances or inconvenience to the occupants/ visitors at site or near the site of work.
- 21. On site, lockable storage space will be given as per availability, the security of which will be the responsibility of the contractor's. The NIEPMD will not be responsible for contractor's materials. The contractor may be required to vacate the storage space as per exigency without any extra cost.
- 22. The contractor shall not directly or indirectly transfer, assign or sublet the contract or any part of it.
- 23. <u>Payment terms & conditions</u>: All the payments for work relating to said work would be made after satisfactory completion/commissioning of work, subject to work being executed in accordance with this Contract and scrutiny by Director NIEPMD, Chennai and submission of bill along with measurement sheets.

- 25. The NIEPMD reserves the right to check the progress of the work and adherence to the technical Specifications etc. any time during the installation phase.
- 26. The agreement may be terminated by the NIEPMD in case the Party does not adhere to the terms of contract.
- 27) All payments by the NIEPMD under this contract will be made only at NIEPMD, Chennai by an account payee Cheque or NIEFT/RTGS after satisfactory completion of work and submission of bill(s) therefore.
- 28) All disputes arising out of or in any way connected with this Agreement shall be deemed to have arisen at Chennai and Courts in Chennai only shall have jurisdiction to determine the same.

7. Warranty & Comprehensive Maintenance

- 1. The complete system shall be <u>under two year warranty</u>, after successful testing, commissioning & handing over to NIEPMD and defect free maintenance during the period.
- 3. Contractor shall make necessary arrangements for keeping the sufficient spares at site to minimize the down time.
- 4. Training to be given to NIEPMD staff for operation & maintenance, troubleshooting, user level training pertaining to system after successful commissioning.

8. Commercial Aspects

a) Penalty for downtime

The NIEPMD authorities may make a complaint about the equipment/service through letter, fax, e-mail, phone, SMS or any other means as the Director, NIEPMD thinks fit or convenient.

On receiving complaint about equipment/service, the vendor will respond and Repair/replace or provide required services within 24 hours, if failed, penalty shall be levied Rs. 500/- per day.

9. Time Frame:-

The vendor should ensure the completion of the work within 30 days from the date of awarding of the contract.

NOTE – If L1 is unable to complete this project in 30 days, OR if L1 fails to successfully carry out the work, then L2 will be requested to match L1 rates and carry out the work and so on.

10. Force majeure:

If either of the parties suffer delay in due execution of their contractual obligation due to the operation of one or more of the force majeure events such as but not limited to, natural disaster, War, earthquake, strikes, Lockouts, fire, epidemics, riots, uncontrollable events, civil commotions etc. the agreed time for the completion of respective obligations shall be extended by a period of the time equal to the period of the delay occasioned by such events. On the occurrence and cessation of any such event, the party affected thereby shall give notice in writing to the other party. Such notices to be given within 15 days of occurrence/cessation of the event concerned. If

the force majeure conditions continue beyond 30 days the parties shall mutually decide about the future course of action.

11. <u>Liquidated Damages</u>

In case of delay in completion of the contract, liquidated damages (L.D.) shall be levied @ 1% of the full value of uncompleted portion of work per week (part of week to be treated as one week) subject to a maximum of 10% of total contract value. If the uncompleted work, restricts the operation of complete system then LD shall be applicable to total value of contract with approval of Competent Authority.

Contract has following activities:

- a) Supply of equipment's.
- b) Creating network for conference mic system and display systems
- c) Installation, Integration and Site Acceptance Testing.
- d) Onsite training.

Delay in any stage of work shall invite Liquidated Damages (LD) according to value of the activity as defined above. LD shall be calculated on per system basis and it shall not be linked with the value of complete supply.
