In this connection, the prospective candidates are advised to follow the below mentioned guidelines:

- i. All RCI Certified Professionals /Personnel has to complete minimum 10 WHO Course out of 12 Courses. Course No. I & VI are mandatory for all Professionals/ Personnel.
- ii. Completion of one course is permitted in a particular day.
- iii. Details of WHO courses completed, copies of Record of Achievements /Certificate of Participation to be submitted to the Council's on the prescribed format (copy enclosed) through e-mail regrci-depwd@gov.in .
- iv. A separate certificate for award of 50 CRE Points to the successful candidates will be issued by the Council and this certificate to be considered as a valid certificate for renewal of registration of the candidate.
- v. Head of the RCI's approved Institutions / University Departments are advised to encourage their teaching and non-teaching staff to undergo these courses latest by 30th June, 2020.
