### ADMISSION NOTIFICATION-2021

National Board of Examination in Rehabilitation (NBER) invites online applications from eligible candidates for admission to **D.Ed.Spl.Ed.(IDD), D.Ed.Spl.Ed.(HI), D.Ed.Spl.Ed.(VI), D.I.S.L.I., DTISL, D.Ed.Spl.Ed.(Db) & D.Ed. Spl.Ed. (MD) Courses** in the field of **Special Education and Disability Rehabilitation** conducted by RCI's approved Training Institutions/University Department(s) across the Country through **Centralized Online Admission Process: 2021**, for the academic session 2021-22. Admissions to these courses will be given based on the marks secured by the candidates at 12<sup>th</sup> examinations.

**Eligibility criteria for Admission to Diploma Level Courses are as under:**

- Special Education Courses:** 10+2 or its equivalent examination from a recognized Central/State Board of Education with minimum 50% marks aggregate.
- Sign Language (DTISL):** Deaf candidates with 10+2 or its equivalent examination from a recognized Central/State Board of Education with minimum 45% marks aggregate. Certificate of Disability (Deaf) and Proficient receptive and productive skills in ISL.

**Reservation Policy** for the SC/ST/OBC/PwD/EWS category for admission will be applicable as per the Govt. Policy of the concerned State/Union Territory.

#### Application Fee:

Rs. 500/- for General and OBC (CL) and Rs. 350/- for SC, ST and EWS. PwD candidates are exempted from application fee.

Fee should be remitted through payment gateway by using a BHIM UPI App/Rupay Card/Debit Card/Net Banking/Paytm/ Card Credit issued by Banks in India. Fee once deposited will not be refunded under any circumstances.
