1. Venue : **Gymkhana Ground, Opposite to Parade Ground, Secunderabad, Telangana (tentative)**
2. Duration : **From 6th to 15th October, 2023**
3. Cost of stall : **Free of cost** to Divyangjan and Organizations working for PwDs
4. Sale of the Products :
 - Expected to attract large no. of visitors.
 - The event will be widely advertised through Newspapers, Social Media and invitations, etc.
 - Cultural events /activities are planned for attracting people to the fair.
5. Business Meets :
 - Business meets would be facilitated for participants giving opportunity for discussions and procurement of bulk sales orders.
 - It will also give an opportunity for guidance to the participants in product development.
6. Other Benefits :
 - Financial assistance would be provided to cover part travelling cost/ daily expenditure to eligible PwDs Artisans/ artists / entrepreneurs/Representatives of the NGO.
 - Support for boarding / lodging would be extended to participants (Only for participants/organisations outside Secunderabad, Telangana)
 - The above facilities shall be extended for the PwD Participant (Minimum 40% Disability) and his Escort on twin sharing basis.
 - In case of NGO, the facility would be restricted to max. two persons only on twin sharing basis.

7. Awards/Recognition : Participating Entrepreneur/ Organization will be judged on set parameters for award in following categories;
- Best displayed stall
 - Best Sales
 - Innovative products &
 - Best women entrepreneur etc.
8. Confirmation and Taking over of Stalls : Confirmation of Participation in the Mega exhibition-cum-fair would be communicated separately. **Participation in the fair would be allowed only in respect of those, whom letter of confirmation has been sent from NDFDC. In respect of confirmed participants, stalls would be allotted on 5th October, 2023.**
