- 2. In case any firm is already providing the medicine to any other Government Hospital and reputed private Hospitals details thereof may also be furnished along with the Tender.
- 3. The following terms and conditions may be kept in view while applying for tender:-
- a) The firm should be in a position to supply medicine on short notice as and when needed (say within 24 hrs.).
- b) All expenses will be borne by the firm for sending the medicine to NIEPMD, Chennai premises.

The invoice will be as per packing for example if the packing is given for 10 X 10 tablets the invoice will be for 10 X 10 tablets and not for 1 tablet similarly, if the packing unit is 2 ml ampoules (10 ampoules) the invoice will be for 10 ampoules and not for 1 or 25 ampoules. The vendor will prepare bill as per receiving copy invoice/challan with details of material accepted.
- I) That in case of change in prescription or if due to any unavoidable circumstances medicine purchased could not be used, the firm will take back such medicine and reimburse the payment made.
