Also highlighted the significance of close care on short as well as long term goals in due reference to IVEP in the up bringing of every client.

Mrs.Ananadhanayaki, Placement officer further proposed the following few IVEP based advises for practice at home for ensured progress.,

- To chart up morning and evening activities based on individual's needs but not on individual's convenience
- To Follow Life skill activities
- To train to perform ADL skills as independently as possible
- To facilitate interaction with neighborhood to develop social skills
- To facilitate Community orientation development near surrounding. To create opportunity for small purchases at nearest petty shop with limited amount.
- To increase one's mobility gradually to travel to nearer reachable places
- To maintain health by balancing diet as well as to avoid unhealthy and unhygienic food
- Above all, to keep the client engaged fully adhering to time schedule



The entire presentation was very keenly honoured by the participants as each & every suggestion placed by Mrs. Anandhanayaki, Placement Officer as happen to be the guidelines to man over the hardships that encountered by the participants in Day to Day realities.
