A guardian is a person who is appointed to look after another person or his property. He or she assumes the care and protection of the person for whom he/she is appointed the guardian. The

guardian takes all legal decisions on behalf of the person and the property of the ward. The occasion for taking care of another person may be his minority that is, a person who has not completed 18 years of age. It can also refer to



guardianship of a person who because of physical and mental deficiencies is unable to take care of himself or his property. From early times, the condition of minority has been the ground for appointment of guardians in all societies.

# SOCIALWORK CASE WORK (STRENGTHS BASED & SOLUTION FOCUSEDAPPROACHES)

Solution-focused practice concentrates on helping people move towards the future that they want and to learn what can be done differently by using their existing skills, strategies and ideas – rather than focusing on the problem. Solution-focused practice as a social work intervention with individuals and families was carried out by social workers having a specialization of

psychiatric social work and the aim was to assist individuals with disabilities and their family members to survive coping with the impossible, foster resilience or enable them to begin to build



platforms of support that could improve their lives.

# GROUP WORK (TASK CENTERED SOCIAL WORK PRACTICE)

The most common forms of group work are with people having mental health difficulties, young carers, children, teenage mothers, children or individual having physical and intellectual disabilities. In this type of intervention the social workers use the collective experience and expertise to share effective solutions, provide mutual support, promotes self-esteem, confidence and identity.

# COMMUNITY DEVELOPMENT

Where problems such as environmental poverty, high



unemployment rates and poor housing, are affecting a community particularly for persons with disabilities, social work intervention at a community development approach is necessary

# THE PSYCHO-SOCIAL THERAPY

One of the chief characteristics of the psycho-social therapy and its major contribution to social work has been the importance attached to the content and the process of 'psycho-social study' as an essential prerequisite to 'psycho-social treatment. Another valuable contribution of the model is that regardless of the nature and the origins of a problem, it is being experienced by a human person and therefore calls for attempts to understand the person and his/her reactions to the problem, as well as understanding the problem itself.

# SERVICE AND PROGRAMME

Based on the rights-based approach, promoting, protecting and ensuring the full and equal enjoyment of all human rights and fundamental freedoms by all persons with disabilities, and in turn promoting respect for their inherent dignity.

Services and programmes by liasoning with all the departments and Units of NIEPMD striving hard to promoting barrier removal and inclusion including health, rehabilitation, assistance and support, environments, education and employment sectors. Service and Programme unit coordinates rehabilitation services. Based on the type of disability (Multiple disabilities and Uni disability) this unit provides individualized services and it is designed to minimize the impact of disabilities and to attain rehabilitation goal, thus facilitating equal access and opportunity for people with disability.

Tele- based rehabilitation services is also available based on the need of the clients.

#### REGISTRATION

Registration of new clients were done by the support staffs at reception by collecting all the details of the client and categories them into UD or MD. The clients were send to Rehabilitation Professionals for Client Situation Analysis. The staff at reception also guide the clients to other departments for further

treatments and follow up sessions and also receive inter office calls, outside calls and guide them appropriately about our services, availability of cottage and other services provided at the institute.



# **CLIENT SITUATION ANALYSIS**

Client Situation analysis unit analyses the need of the clients as part of a preliminary phase by collecting information about clients using the Case Work method. Based on the condition and need of the clients they are referred to other departments for further assessment. Management plan will be prepared after all

the assessment completed by other departments Social Work professionals educate the parents/caregivers about the condition of the client and explain the management plan to avail the services at NIEPMD as well as the home-based learning programmes.



#### **RESPITE CARE**

Respite care unit provides relief for primary caregivers from the ongoing responsibility of caring for an individual with special needs. Although respite care unit allows primary care takers and the other family members to take a short pause from their continuous task of caregiving to their loved ones. It also aims at creating opportunities for family members to get respite time in order to fulfil other responsibilities.
