- 1. Tender will be remain open for e-bidding on NIC e-procurement portal URL http://eprocure.gov.in/eprocure/app" up to 01st August 2022, 04.00 PM.
- 2. EMD amount of Rs. 5,00,000/- & Tender fee of Rs. NIL should be paid online through NEFT or RTGS in NIEPMD account and payment receipt to be uploaded with tender document. Bids without EMD amount shall not be considered for further evaluation in case otherwise exempted by Govt. Tender received without EMD amount or lesser amounts will be summarily rejected. No further correspondence will be accepted on the subject.
- 3. Exemption of EMD for NSIC, MSME etc. will be considered purely based on government orders in force.
- 4. The tender shall remain open for acceptance for 60 days from the date of opening of tenders by National Institute for the Empowerment of Persons with Multiple Disabilities (NIEPMD). The time limit for acceptance may be extended by NIEPMD at its discretion for such further period, as it may notify
- 5. Technical Bid shall consist of EMD payment proof for the required amount as per the tender documents and technical details: Leaflets / information brochures (if any) showing the technical and general details of the material offered shall also be enclosed with the technical bid, scanned copy if any, from tender specifications, clause-wise and commercial terms and conditions should be clearly mentioned in the sheet as specified. - 6. No alteration or amendments shall be allowed after submission and opening of the tenders.
- 7. The bidders whose bids are accepted for technical evaluation will submit the product sample for technical evaluation within 10 days from acceptance of their bids. The bidders may be asked to produce original document during technical evaluation by NIEPMD authorities. Non production of sample and required document to technical committee may leads to rejection of bids.
- 8. The items made of plastic / paints should be non-toxic with no sharp edges as a safety measures and no material made using wax is permitted. (Non-toxic certificate from Govt. approved laboratories to be uploaded, if so required)
- The financial bids of technically qualified bidders only will be opened. The time and date of opening of price bids shall be intimated to the technically qualified bidders through eprocurement online.
- 10. The Rate contract will be awarded for supply of Android / IOS Tablets and Smart Phones to L-1 bidder from the qualified bidder on item wise basis.
- 11. Bidder must submit a certificate of undertaking that he is in position to supply the materials with a credit of 30 days after clear receipt of materials. Certificate must have its issuing date on it, and date should be on or after issuing of tender date. Non submission of certificate with technical bid will leads to rejection of bid.
- 12. Bidder must submit a certificate of undertaking that quoted rate will remain firm for one year from the date of award of contract. No request for change of rates will be made during contract period i.e. one year. Non submission of certificate with technical bid will leads to rejection of

bid. Certificate must have its issuing date on it, and date should be on or after issuing of tender date.

- 13. The bidder will give the certificate that under no condition product will be supplied more than MRP. In case product MRP decrease and product quoted value in contract become more than MRP, the quoted value will also be reduced as per pro Rata basis. Non submission of certificate with technical bid will leads to rejection of bid. Certificate must have its issuing date on it, and date should be on or after issuing of tender date.
- 14. The Director, NIEPMD, reserves all rights to reject any tender including of those tenderers who fail to comply with the instructions without assigning any reason what so ever and does not bind itself to accept the lowest or any specific tender. No manual bids will be entertained under any circumstances.

The Tender document attached must be direct, concise, and complete and arranged in an organized and structured manner.

To participate in online bidding process, Bidders must procure a Digital Signature Certificate as per Information Technology Act-2000 using which they can digitally sign and encrypt their electronic bids. Bidders can procure the same from any CCA approved certifying agency, i.e. TCS, Safecrypt, Ncode, eMudhra etc. Bidders who already have a valid Digital Signature Certificate (DSC) need not procure a new DSC.

- 1. The bidder should have their own agency facility. Proof to be uploaded in the Tech Bid.
- 2. The applying Firm/ Company must have an annual average turnover of last 03 financial years not less than Rs. 1.0 crores (i.e. FYs 2017-18, 2018-19, 2019-20 OR 2018-19, 2019-20, 2020-21). Proof of certificate for turnover is required to be uploaded with the tender (CA attested certificate and copy of the balance sheet with profit and loss account should be uploaded with technical bid.)
- 3. The bidder should furnish tax audit report (for the proof of annual turnover of last 03 accounting years i.e. FYs 2017-18, 2018-19, 2019-20 OR 2018-19, 2019-20, 2020-21 with form No. 3CB & 3CD downloaded from Income Department).

- 8. Copy of Manufacturing license in case OEMs to be attached with technical bid.
- 9. All pages of the tender papers should be signed, stamped and dated including the annexures and submitted online through scanned copies.
- 10. Bidders should provide brief profile of their work experience for the last three years along with the relevant samples of the similar work done earlier.
- 11. The rates quoted are valid for the contract period. In case of any increase in rates quoted rate will remain valid for contract period. In case reduction in product rate the quoted rate will be recalculated on pro rata basis and benefit of rate reduction will be transferred to Institute. Taxes applicable at the time of invoice will be paid by institute.
- 12. The tender received through fax / e-mail or received by post etc. will not be accepted. The parties have to ensure the uploading of bids well in time.
- 13. The successful bidder will be required to execute a performance security. A sum of Rs.10,00,000/- (Rupees Ten Lakhs Only) will have to be deposited in the form of Bank Guarantee/Demand Draft on award of the rate contract to NIEPMD, Chennai as performance security. The bidder should see that the bank guarantee validity should be Six months over and above the contract period.
- 14. The materials should be delivered at Chennai and to other parts of the country. The transportation charges in the <u>cheapest</u> available mode to Chennai and other locations in India will be paid by NIEPMD on production of original transport receipts. No other charges will be paid.
- 15. The rates shall be on F.O.R at NIEPMD, Chennai and its CRCs and extension centers Regional Centers of the locations as per the requirement within India.
- **16.** Prices shall be firm until the completion of work or supply and no enhancements of rates will be done / is permitted because of any escalation during the period of rate contract.
- 17. The statutory deductions like TDS, WCT, etc., as per standard norms will be made from the bills.
- 18. The supply of the Tablets / Smart Phones should be done within 15 days for local (Within Chennai / Tamilnadu) and 30 days in other parts of India including North-Eastern states from the date of Purchase Order and incase of any delay penalty will be charged as per rules. The institute reserves the right to reduce the period of supply of materials for shorter duration also, in urgent situations
- 19. Pre-delivery inspection of the Android / IOS Tablets and Smart Phones may be carried out by NIEPMD at NIEPMD, Chennai or at the location of agency supplying the materials.
- 20. The quality should be maintained strictly. Any deviations found in the materials supplied after inspection or materials not found in agreement as per contract, the agency is liable to be debarred/blacklisted from future participation in the NIEPMD tenders.
- 21. The supply of Tablets / Smart Phones shall be carried out strictly in accordance with the terms & conditions and specifications as stipulated in the tender, in the approved workman like manner and as per standard practice. Materials supplied shall be of high quality and should be non-toxic.
- 22. The Contractor shall follow all safety rules and security procedure that are in vogue and applicable during the supply / execution of work.

- 23. NIEPMD reserves the right to nominate and enter into rate contract with more than one agency to undertake the work at the L1 rates.
- **24.** Payment will be released after the satisfactory receipt of material at the designated locations and certification by the concerned co-ordinator at NIEPMD and no advance payment will be entertained.
- 25. The total cost quoted should be exclusive of taxes. Applicable taxes should be mentioned separately. Tax applicable at the time of invoice will be paid. ZERO / No tax in the BOQ will not be accepted and such offer may be rejected.
- 26. The price quoted should be valid for twelve months. NIEPMD, based on various program/activities, the requirements may increase or decrease the estimated Quantity.
- 27. NIEPMD reserves the right to accept / reject / select more than one Agency and to annul the bidding process of any or all bids at any time prior to award of contract without thereby incurring any liability to the affected bidders.
- 28. The tender will be appraised by committee formed by NIEPMD.
- 29. NIEPMD shall without prejudice to its other remedies under the contract, deduct from the Contract price, as Liquidated Damages a sum equivalent to 2.5% of the price of delayed Goods or unperformed services for delay of each day until actual delivery or performance, up to a maximum deduction of 20% of the contract price. Once the maximum is reached, NIEPMD may consider termination of the contract and can forfeit the Performance Guarantee amount.
- 30. The payment will be made within thirty working days after the clear receipt of supply.
- 31. Bidder should furnish self-declaration regarding currently not black listed by any State / Central government. Certificate must have its issuing date on it, and date should be on or after issuing of tender date.
- 32. In case of any dispute, the settlement will be made in the Courts of Chennai only.

33. Abnormal Rates

If it is noticed that the unit rates quoted by the Tenderer for any items are unusually high or unusually low, it will be sufficient cause for rejection of the tender unless the Institute is convinced about the reasonableness of the unit rates on scrutiny of the analysis for such unit rate to be furnished by the tenderer on demand.

34. <u>Deviations to Tender Clauses:</u>

Tenderers are advised to submit the tenderers strictly based on the terms and conditions and specification contained in the Tender Documents and not to stipulate any deviations. Conditional tenders are liable to be rejected.

35. Acceptance / Rejection of Tender

- i) Institute does not bind itself to accept the lowest tender.
- ii) Institute also reserves the right to accept or reject any tender in part or full without assigning any reason whatsoever.
- iii) Institute also reserves the absolute right to reject any or all the tenders at any time solely based on the past unsatisfactory performance by the bidder(s) the opinion/decision of NIEPMD regarding the same shall be final and conclusive.

36. Sufficiency of Tender:

The Contractor / Supplier shall be deemed to have satisfied himself before tendering as to the Correctness and sufficiency of his tender for the works and of the rates and prices quoted in the Schedule of Quantities, which rates and prices shall except as otherwise provided, cover all his obligations under the contract and all matters and things necessary for the proper completion and maintenance of the Works.

37. Materials

All materials to be provided by the Contractor / Supplier shall be in conformity with the specifications laid down in the tender document and the Contractor shall, if requested by the Officer- in-Charge, furnish proof to the satisfaction of Officer- in-Charge in this regard. The Equipment should have required National and International quality and security certification. Wherever possible all equipment should have ISI/BIS/CE/FCC/ROHS/WEEE certification (as applicable)



Equipment having proper certifications from national and international agencies will only be accepted. Also equipment having more certification will be given priority in technical evaluation. Claim of certification should be proved by the vendor duly supported by documents.

Agencies quoting the Equipments must produce OEM / Authorised distributer / Authorised dealer certificate duly supported by proper testimonials. Original copies of all these documents should be produced in technical evaluation meeting,

In case of any item should be of "Proprietary" in nature than proprietary certificate should be uploaded by the bidder and claim will be evaluated in term of Rule No. 166 of GFR-2017.

38. Warranty & Repairs

- a) The quoted product must have <u>under One-year onsite warranty</u>, from date of product invoice. Product serial number should be mentioned with warranty details on invoice. GST invoice should be provided and NIEPMD GSTIN should be used for invoicing purpose.
- **b)** For maintainability of products sufficient after sale service centers should be available for product repair after warranty period. List of such centers should be uploaded with technical bid for technical evaluation.
- c) It will not be open for the contractor to refuse maintenance of any equipment supplied under this contract during the currency of contract.
- **d)** The contractor shall be responsible for any loss or damage caused to any of the machines owing to negligence on his part
- e) In case of any dispute, the settlement will be made in the Courts of Chennai only.
- f) Firm must provide customer satisfaction letter from at least two customers from govt. department/PSU while submitting the technical bids.
- **g)** Firm must have sufficient numbers of qualified and experienced engineers and a list of those engineers must be enclosed with technical bids.
- h) Establishment of the firm must be more than 03 years old and the firm should be in same business at least since 03 years.
- i) Ensuring that the covers, screws, switches etc. are firmly fastened in respect of each equipment after repair and maintenance of product.

39. Standard Conditions of Contract:

The Bidder, is required to give confirmation of their acceptance of the Standard Conditions of the Contract mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder (i.e. <u>Contractor/Supplier in the contract) as selected by the customer.</u> Failure to do so may result in rejection of the Bid submitted by the Bidder/firm.

(a) <u>Law:</u> The Contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.

(b) <u>Effective Date of Contract:</u>

The contract shall come into effect on the date of award of contract and shall remain valid until the completion of the obligations of the parties under the contract. The deliveries and supplies and performance of the services shall commence from the effective date of the contract.

- (c) <u>Arbitration:</u> All disputes or differences arising out of or in connection with the contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the Contract or relating to services or performance, which cannot be settled amicably, may be resolved through arbitration. The standard clause of arbitration is given below:
 - (i) All disputes of differences arising out of or in connection with the present contract including the one connected with the validity of the present contract or any part thereof, should be settled by bilateral discussions.
 - (ii) Any dispute, disagreement of question arising out of or relating to this contract or relating to construction or performance (except as to any matter the decision or determination whereof is provided for by those conditions), which cannot be settled amicably, shall within sixty (60) days or such longer period as may be mutually agreed upon, from the date on which either party informs the other in writing by a notice that such dispute, disagreement or question exists, will be referred to a sole Arbitrator.
 - (iii) Within (60) days of the receipt of the said notice, an arbitrator shall be nominated in writing by the authority agreed upon by the parties.
 - (iv) The sole Arbitrator shall have its seal in Chennai or such other place in India as may be mutually agreed to between the parties.
 - (v) The arbitration proceedings shall be conducted under the Indian Arbitration and Conciliation Act, 1996 and the award of such Arbitration Tribunal shall be enforceable in Indian Courts only.
 - (vi) Each party shall bear its own cost of preparing and presenting its case. The cost of arbitration including the fees and expenses shall be shared equally by the parties, unless otherwise awarded by the sole arbitrator.
 - (vii) The parties shall continue to perform their respective obligations under this contract during the pendency of the arbitration proceedings except in so far as such obligations are the subject matter of the said arbitration proceedings.

(Note: In the event of the parties deciding to refer the dispute/s for adjudication-to an Arbitral Tribunal then one arbitrator each will be appointed by each party and the case will be referred to the Indian Council of Arbitration (ICADR) for nomination of the third arbitrator. The fees of the arbitrator appointed by the parties shall be borne by each party and the fees of the third arbitrator, if appointed, shall be equally shared by the Customer and Contractor.

(d) <u>Agents/Agency Commission:</u> The firm/Bidder contractor/Supplier confirms and declares to the customer that the contractor is the original provider of the services referred to in this Contract and has not engaged any individual or firm, whether Indian or foreign whatsoever, to intercede, facilitate or in any way to recommend to the Government of India or any of its functionaries whether officially or unofficially, to the award of the contract

to the contractor, nor has any amount been paid, promised or intended to be paid to any such individual or firm in respect of any such intercession, facilitation or recommendation. The contractor agrees that if it is established at any time to the satisfaction of the customer that the present declaration is in any way incorrect or if at a later stage it is discovered by the customer that the contractor has engaged any such individual/firm, and paid or intended to pay any amount, gift, reward, fees, commission or consideration to such person, party, firm or institution, whether before or after the signing of this contract the contractor will be liable to refund that amount to the customer. The contractor will also be debarred from entering into any supply Contract with the Government of India for a minimum period of Five years. The customer will also have a right to consider cancellation of the Contract either wholly or in part, without any entitlement or compensation to the Contractor who shall in such an event be liable to refund all payments made by the customer in terms of the contract along with interest at the rate of 2% per annum above 18% penal rate. The customer will also have the right to recover any such amount from any contracts concluded earlier with the Government of India, or with Legislative Department.

- (e) Access to Books of Accounts: In case it is found to the satisfaction of the customer that the contractor has engaged an Agent or paid commission or influenced any person to obtain the contract as described in clauses relating to Agents/Agency Commission and penalty for use of undue influence, the Contractor, on a specific request of the customer shall provide necessary information/inspection of the relevant financial documents/information.
- (f) <u>Non-disclosure of Contract documents:</u> Except with the written consent of the customer, contractor shall not disclose the contract or any provision of the contract or information related to services thereof to any third party.
- (g). <u>Termination of Contract</u>: The customer shall have the right to terminate this Contract in part or in full in any of the following cases: -
 - (a) The delivery of the product & services is delayed for causes not attributed to Force Majeure for more than time mentioned in tender document.
 - (b) The contractor is declared bankrupt or becomes insolvent. The delivery of the product & services is delayed due to causes of Force Majeure by more than 01 months provided Force Majuro clauses is included in contract.
 - (c) The customer has noticed that contractor has utilized the services of any agent in getting this contract and paid any commission to such individual/company etc.
 - (d) As per decision of the Arbitration Tribunal.
 - (e) If the delivery of the product & services are not found satisfactory as per Tender terms.
 - (f) By Director NIEPMD at any time without assigning any reason.
 - (g) <u>Notices:</u> Any notice required or permitted by the contract shall be written in the English / Hindi language and may be delivered personally or may be sent by E-mail /FAX or registered pre-paid mail/airmail, addressed to the last known address of the party to whom it is sent.
- (h) <u>Transfer and Sub-letting:</u> The firm/bidder has no right to give, bargain, sell, assign or sublet or otherwise dispose of the contract or any part thereof, as well as to give or to let a third party take benefit or advance of the present Contract or any part thereof.
- (i) Amendments: No provision of present contract shall be changed or modified in

any way (including this provision) either in whole or in part except by an instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.

- (j). **Fall Clause:** The following fall clause will form part of the contract placed on successful Bidder:
- (a) The price charged for the services supplied under the contract by the contractor/firm shall in no event exceed the lowest price at which the contractor provides the services of identical description to any persons / organization including the customer or any department of the Central Government or any department of state government or any statutory undertaking of the central or state government as the case may be during the period till performance of all services placed during the currency of the contract is completed.
- (b) If at any time, during the said period the contractor/firm reduces the service price or offer to provide services to any person / organization including the customer or any department of central Government or any Department of the State Government or any Statutory undertaking of the Central or State Government as the case may be at a price lower than the price chargeable under the contract. Such reduction of services offer of the price shall stand correspondingly reduced.

(k). Risk & Expense clause:

- 1. Should the services thereof not be delivered within the time or times specified in the contract documents, or if defective services is made in respect of the services thereof, the customer shall after granting the contractor seven days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of contract, to declare the contract as cancelled either wholly or to the extent of such default.
- 2. Should the services thereof not perform in accordance with the specifications/parameters provided by the customer during the check proof tests to be done by the customer, the customer shall be at liberty, without prejudice to any other remedies for breach of contract, to cancel the contract wholly or to the extent of such default.
- 3. In case of a contractual breach that was not remedied within 07 days, the customer shall, having given the right of first refusal to the contractor be at liberty to provide services from any other source as he thinks fit, of the same or similar description to services.
- 4. Any excess of the services price, cost of services or value of any services procured from any other contract as the case may be, over the contract price appropriate to such default or balance shall be recoverable from the firm/Contractor by Customer.

(I) Force Majeure Clause:

a. Neither party shall bear responsibility for the complete or partial non-performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract), if the nonperformance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or

- Actions of State Authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.
- b. In such circumstances the time stipulated for the performance of an obligation under the present contract is extended correspondingly for the period of time of action of these circumstances and their consequences.
- c. The party for which it becomes impossible to meet obligations under this contract due to Force Majeure conditions, is to notify in written form the other party of the beginning and cessation of the above circumstances immediately, but in any case not later than 10 (Ten) days from the moment of their beginning.
- d. Certificate of a Chamber of Commerce (Commerce and Industry) or other competent authority or organisation of the respective country shall be a sufficient proof of commencement and cessation of the above circumstances.
- e. If the impossibility of complete or partial performance of an obligation lasts for more than one month either party hereto reserves the right to terminate the contract totally or partially upon giving prior written notice of 15 days to the other party of the intention to terminate without any liability other than reimbursement on the terms provided in the agreement for the goods received.
