#### INSTRUCTIONS/TERMS & CONDITIONS FOR THE TENDERER

- 1. The vendor/ Manufacturer/Retailers/Firms/Shopkeepers etc. who are in the business of supply of Readymade / Stitched School Uniform / Tailors etc. with an annual sale of Rs. 2,00,000/- (Rs. Two Lacs only) are eligible to participate in the tender.
- **2.** The qualified bidder will be required to take the measurement of school student and the uniform should be stitched as per their actual sizes.
- **3.** The bidders are requested to visit the school on pre-bid meeting day or on any working day Monday to Friday (Except on Govt. holiday) between 10.00 AM to 03.00 PM for checking the uniform type, pattern & cloth quality.
- **4.** EARNEST MONEY DEPOSIT (EMD): Tender should be accompanied with earnest money of Rs. 10,000/- (Rupees Ten Thousand only) through demand draft in favour of "Director, NIEPMD". EMD exemption will be available as per existing Govt. of India norms. The earnest money deposited (EMD) of unsuccessful firms will be refunded immediately after finalization of the tender. No interest will be payable on earnest money deposited (EMD). The EMD amount can be deposited through online mode also as per below mentioned details: -

- **5. SAMPLE:** The samples of uniform can be seen by the bidders by visiting the institute by fixing appointment with school. The qualified bidder should be required to submit the uniform sample for approval be NIEPMD authorities before execution of complete order. The samples should be as per specification provided. The vendor should submit Samples with an Embroidered Logo of Institute.
- **6.** The rates quoted by the vendor should be F.O.R destination i.e. NIEPMD, Muttukadu, Kovalam, Chennai including all taxes, freight etc. Rates quoted shall remain valid for one year from the date of issue of supply order.
- 7. The acceptance of tender will have the binding effect on the vendors and will have to supply the required items/ordered items within the period stipulated in supply order.
- **8.** Security Deposit: The successful firms will have to deposit performance security @3% of the total value of the order within 7 days of issuance of letter of intent by the Institute and the security deposited in connection with any other similar tender will not be considered against this tender. Thereafter, the supply order will be issued for the supply for stitching of School Uniform. If the successful vendor fails to submit requisite security deposit within prescribed 7 days, the Earnest Money will be forfeited.

- **9.** <u>Inspection of Material</u>: The NIEPMD Purchase Committee may inspect the goods supplied by the vendor in response to the purchase order/intent in the school. The NIEPMD Purchase Committee reserves all rights to reject the goods supplied if same are not found in accordance with the required description/specifications.
- **10.** The successful vendors shall supply the goods/material to the school within 30 days from the date of placing the supply order. The payment shall be released only on the satisfactory inspection of material as per supply order/samples by the committee andby completing all the formalities.
- 11. Measurement of each child must be taken by the successful bidder/ tailor before stitching the uniform so that the uniform is correctly fitted to the child.
- **12.** The timely deliver/dispatch as stipulated in the supply order has to be strictly adhered to by the firm and in case of any request for extension of time made by the said vendors in writing, the same may considered by the DR (Admin) / Director, NIEPMD.
- **13. PENALTY:** The competent authority reserves the right to impose penalties in the following exigencies:
- (a) In case the vendor fails to complete the supply within time period as given in supply order, then penalty @ 0.5% per week or part thereof subject to maximum limit of 10%, on the value of delayed portion of supply will be levied. However, Institute Purchase Committee may relax the penalty clause if it is satisfied that reasons for the delay were largely due to circumstances beyond the control of vendor
- **14.** In case, there is any variation in the specifications / samples approved vis-à-vis the supply received, then that portion of supply will be rejected and the vendor shall be liable to supply the goods as per specification within a period of 10 days.
- **15.** In case of defected supply, the vendors will be informed to lift the said supply within 10 days from the date of issuance of said letter by Director, NIEPMD at his own cost. In the event of non-lifting of said defective goods within the specified period by the vendors, the NIEPMD will not be responsible in any manner for the loss or damage if any, caused to the said goods.
- 16. FORCE MAJEURE: If the performance in whole / part by the vendors is prevented / delayed by any one or more of the force majeure events including but not limited to war, hostilities, civic commotion, acts of public enemy, sabotage, fire, floods and other natural causes, explosion, epidemics or non-availability of government controlled raw material under order / instruction of Central / State Govt. regulations, strikes, lockouts, agitations, embargo, act of civic or limitary authorities, the party shall not be made liable for the loss of damage due to delay or failure to perform during the currency of force majeure event provided that the happening is notified in writing (with documentary proof) within 7 days from the date of occurrence. The work shall be resumed as soon as practicable after the force majeure event ceases to exist.

- 17. The tender shall be opened on 17<sup>th</sup> Apr 2023 at 04.00 P.M at 3<sup>rd</sup> Floor NIEPMD, Conference Hall, Muttukadu, Chennai. In the event of the date of receipt or opening of tender being declared a Holiday, the due date of receipt/opening of the tender will be the next working day at the same hours.
- 18. This tender is non-transferable.
- **19.** The Institute Purchase Committee, or other sanctioning authority reserves the right to reject any tender or all the tenders without assigning any reason thereof.
- **20.BLACK LISTING OF APPLICANT/FIRMS:** The applicant/firms participating in the tender and short listed after due processing of tender can be blacklisted for non-fulfilling the requisite requirements of the tender documents/supply order or for concealing any information or for furnishing any false documents/statements in the tender.
- **21. ARBITRATION:** In the event of any dispute or difference the same shall be referred to the sole arbitrator Director, NIEPMD, whose decision shall be final and binding on the parties thereto. The provision of Arbitration & Conciliation Act, 1966, shall apply to the said arbitration proceedings.
