1.0 GENERAL TERMS

- (b) EMD amount of Rs. 60,000/- & Tender fee of Rs. 1,000/- (non-refundable) should be paid online through NEFT or RTGS in NIEPMD account and payment receipt to be uploaded with tender document. Bids without Tender Fee and EMD amount shall not be considered for further evaluation Tender received without Tender Fee or lesser amounts will be summarily rejected. No further correspondence will be accepted on the subject.
- (c) Units registered with National Small Industries Corporation (NSIC), Small Scale Industrial (SSI), are exempted from payment of EMD for the item tendered and subject to registration certificate being valid as on date of quotation. 6.0 VALIDITY OF OFFER

9.0 FIRM RATES

GENERAL CONDITIONS OF CONTRACT

- **1.** Where the context so requires, words importing the singular only also include theplural and vice versa.
- 2. Institute shall mean "National Institute for Empowerment of Persons with Multiple Disabilities (NIEPMD)."(An Autonomous Body under DEPwD, MSJ&E, Government of India) having its registered office at EastCoast Road (ECR), Muttukadu, Kovalam (Post), Chennai 603 112 (Tamilnadu).
- **3.** The Contractor / Supplier is required to approach the Institute for execution of agreement for the said work as per the prescribed proforma to be provided by theInstitute on a non-judicial stamp paper of Rs.100/- within 10 days from the issueof the letter of award.

4. Contract Documents:

The Contractor / Supplier shall be provided, free of charge, one certified true copy of the Contract Documents.

5. Works to be carried out:

The work to be carried out under the Contract shall, except as otherwise provided inthese conditions, include all labour, materials, taxes tools, plant, equipment andtransport which may be required in preparation of and for and in the full and entireexecution and completion of the works.

6. Inspection of Site:

The Contractor / Supplier shall inspect and examine the Site and its surrounding andshall satisfy himself before submitting his tender as to the nature of the Site, thequantities and nature of works and material necessary for the completion of the Worksand the means of access to the Site, he may require and in general shall himself obtainall necessary information as to risks, contingencies and other circumstances whichmay influence or affect this tender.

7. Sufficiency of Tender:

The Contractor / Supplier shall be deemed to have satisfied himself before tendering asto the Correctness and sufficiency of his tender for the works and of the rates andprices quoted in the Schedule of Quantities, which rates and prices shall except asotherwise provided, cover all his obligations under the contract and all matters andthings necessary for the proper completion and maintenance of the Works.

8. Security Deposit:

8.1 Total security deposit shall be 10 % of the accepted tender cost and shall be deducted from the payment to be made to the Contractor / Supplier. Earnest Money deposited shall be adjusted in the security deposit. The security deposit can be accepted in the form of unconditional Bank Guarantee of nationalized bank/scheduled bank.

- 8.2 **Refund of Security deposit:** Security deposit shall be refunded to theContractor / Supplier after successful completion of defect liability period of 36 months from the completion of work.
- 8.3 No interest shall be payable to the Contractor / Supplier on the Security Depositfurnished/ recovered from the Contractor / Supplier, by the Institute.

9. Time and Extension for Delay:

- 9.1 The time allowed for execution of the works as specified in the Appendix or the time in accordance with these conditions shall be the essence of the Contract. The execution of the works shall commence from the 7th day afterthe date on which the Institute issues Work Order to commence the work.
- 9.2 If the work be delayed by
 - (a) Force majeure or
 - (b) Serious loss or damage by fire, or

(c) Civil commotion, local combination of workmen strike or lockout, affectingany of the trades employed on the work, or

(d) Any other cause, which, in the absolute discretion of the authority mentionedin Appendix, is beyond the Contractor's/Supplier's control;

9.3 Then upon the happening of any such event causing delay, the Contractor/ Supplier shall immediately give notice thereof in writing to the Officer- in-Charge purchase section but shall nevertheless use constantly his best endeavors to prevent ormake good the delay and shall do all that may be reasonably required to thesatisfaction of the Officer- in-Charge to proceed with the Works.

10. The Contractor / Supplier shall arrange, at his own expense, all tools, plant and

equipment hereafter referred to as (T & P) labour, P.O.L. & electricity required for completion of the work.

11. FORCE MAJEURE

Any delays in or failure of the performance of either party herein shall not constitutedefault hereunder or give rise to any claim for damages, if any, to the extent suchdelays or failure of performance is caused by occurrences such as Act of god or thepublic enemy; expropriation or confiscation of facilities by Government authorities, or in compliance with any order or request of any Governmental authorities or dueacts of war, rebellion or sabotage or fires, floods, explosions, riots or illegal jointstrikes of all the workers of all the Contractor / Supplier s.

12. MATERIALS

All materials to be provided by the Contractor / Supplier shall be in conformity with the specifications laid down in the contract and the Contractor shall, if requested by the Officer- in-Charge, furnish proof to the satisfaction of Officer-in-Charge in this regard.

13 Specifications

- 13.1 The details of commercial gym equipment specification/requirements and relevant information have been provided in **Annexure –II Scope of work.**
- 13.2 If particular commercial gym equipment including accessories is available as both indigenously and imported, then offers may be provided for both the equipment/accessories i.e. indigenous and imported, separately in Indian currency.
- 13.3 It must be noted that the commercial gym equipment to be supplied to NIEPMD shall have a minimum guarantee/warrantee of 03 years (36 Months) from the date of successful installation.
- 13.4 The firms are also requested to offer their rates for providing Annual Maintenance Contract (AMC) for the period of another 02 years after expiry of guarantee/warrantee available at the time of installation (i.e. 36 months from date of installation). However, it shall be the sole prerogative of NIEPMD to decide as to whether or not AMC contract may be entered at the time of placing the supply order.
- 13.5 **Option Clause:** During the currency of the contract, the buyer (NIEPMD, Chennai) can exercise an option to procure an additional 50% of the original contracted quantity in accordance with the same terms & conditions of the present contract. This will be applicable within currency of contract. The Bidder is to confirm the acceptance of the same for inclusion in the contract. It will be entirely the discretion of the Buyer to exercise this option or not.
- 13.6 **Repeat Order Clause:** The buyer (NIEPMD, Chennai) can order up to 50% quantity of the items under the present contract within six months from the date of supply/successful completion of the work, the cost, terms & conditions remaining the same. The bidder is to confirm acceptance of this clause. It would be entirely the discretion of the buyer to place the repeat order or not.
- 13.7 **Apportionment of Quantity:** If there is apprehension that the L 1 may not have the capacity to supply the entire requisite quantity within the defined time the order may be placed on L 2, L 3 and so on for the balance quantity at L 1 rates, provided this is acceptable to them. The ratio of splitting of supply order will be worked as per the capability of the L 1 firm

14. Warranty:-

- 14.1 Gym and Fitness Equipments should be under three years free on-site comprehensive warranty and support from the date of installation, including free provision of spare parts, kits as and when required.
- 14.2 If the Equipments remains down beyond 48 hours, the firm will be required to provide a stand-by of the same or higher configuration, failing which the Director, NIEPMD Chennai will arrange for the Equipments on rental basis at the rate decided by the Director, NIEPMD, Chennai, which shall be final and binding, and the cost thereof shall be adjusted against the Security Deposit/Bank Guarantee.

- 14.3 Warranty period begins from the date of satisfactory installation and commissioning at location certified by Officers of NIEPMD.
- 14.4 If the Gym or Fitness Equipments is down beyond 48 hours, penalty at the rate of Rs. 500/- (Rupees Five hundred only) per day per fault will be charged.
- 14.5 Supplier shall visit the site at least once in every six months to carryout preventive maintenance and fine-tune of the Equipments besides regular service calls during the warranty period.
- 14.6 On completion of the Warranty period, the unconditional Bank Guarantee without any interest accrued shall be released after satisfying that proper free warranty support has been provided during warranty period of three year for all the items. If considered necessary, suitable amount of penalty shall be recovered from the vendor out of their duepayments or from their Security Deposit or by raising claims, while releasing the Security Deposit.

14.7 The supplier has to provide training on operation of Gymand Fitness Equipments to the officials of NIEPMD. In addition to above, vendor would also provide onsite training to end-user at the time of installation of equipment.

14.8 Any disputes arising out of this tender will be under the Jurisdiction of Court of Jabalpur only.

Option Clause: - During the currency of the contract, the buyer (NIEPMD, Chennai) can exercise an option to procure an additional 50% of the original contracted quantity in accordance with the same terms & conditions of the present contract. This will be applicable within currency of contract. The Bidder is to confirm the acceptance of the same for inclusion in the contract. - 25. - 26. Apportionment of Quantity: If there is apprehension that the L 1 may not have the capacity to supply the entire requisite quantity within the defined time the order may be placed on L 2, L 3 and so on for the balance quantity at L 1 rates, provided this is acceptable to them. The ratio of splitting of supply order will be worked as per the capability of the L 1 firm

15. Labour:

a.) The Contractor / Supplier shall employ its labour/ workmen in sufficient numbers complete the work in the stipulated time. The Contractor / Supplier shall notemploy in connection with the Works any person who has not completed eighteen years of age.

b.) All the workers or employees deployed by the Contractor/Suppliers shallconsider the employees of Contractor / Supplier and Institute shall not haveany liability what so ever in nature in regard to such workers/employees.

c.) The Contractor / Supplier shall comply with all statutory norms of Central/ StateGovt. with regard to labour/ workmen employed by him. Violation of any suchnorm shall be the sole responsibility of the Contractor / Supplier. TheContractor/Supplier shall indemnify and keep indemnified the Instituteagainst all such claims arising out:

i) Of third party loss/ damage to life or property caused by/ during execution of the work.

ii) Of loss/ damage to the workmen engaged by the Contractor / Supplier duringexecution of the work

iii) Due to non-compliance of applicable PF/ Labour laws, ESI regulations etc.

16. Inspection and Approval:

The Director, NIEPMD or his representative shall have powers at any time to inspectand examine any part of the Works and the Contractor / Supplier shall give suchfacilities as may be required for such inspection and examination.

17. Liquidated Damages for Delay

Time is essence of the contract. In case the CONTRACTOR / SUPPLIER fails tocomplete the whole work within the stipulated period, he shall be liable to payliquidated damages @ 2..5% of the value of contract per week and orpart thereof of the delay subject to a maximum of 25% of the valueof the contract. The amount of Compensation may be adjusted or set-off against anysum payable to the Contractor / Supplier under this or any other contract with theInstitute.

18. Defect Liability Period

The Contractor / Supplier shall be responsible to make good and remedy any defectin the work executed within defect liability period of Three year which shall bereckoned from the date of completion of the works to the Institute.

19. Instruction and Notices:

- 19.1 Subject as otherwise provided in this contract, all notices to be given on behalfof the Institute and all other actions to be taken on its behalf may be given or taken by the Officer- in-Charge or any officer for the time being entrusted withthe functions, duties and powers of the Officer-in-Charge.
- 19.2 All instructions, notices and communications, etc., under the contract shall begiven in writing and if sent by registered post to the last known place of abodeor business of the Contractor / Supplier shall be deemed to have been served on the date when in the ordinary course of post these would have been delivered tohim.

19.3 Foreclosure of Contract in Full or in Part due to Abandonment or

Reduction in Scope of Work.

If at any time after acceptance of the tender the Institute shall decide to abandon or reduce the scope of the works for any reason whatsoever and hencenot require the whole or any part of the Works to be carried out the Engineer- in-Charge shall give notice in writing to that effect to the Contractor / Supplier andContractor / Supplier shall have no claim to any payment of compensation orotherwise whatsoever, on account of any profit or advantage which he mighthave derived from the execution of the works in full but which he did not derivein consequence of the foreclosure of the whole or part of the works.

19.4 The Contractor / Supplier shall be paid at Contract rates full amount for worksexecuted at Site as certified by the Officer- in-Charge.

20. Cancellation of Contract in Full or in Part:

If the Contractor / Supplier / Supplier:

- a. At any time makes defaults in proceeding with the Works with due negligence and continues to do so even after a notice in writing of 7 days from the Purchase Department; or
- b. Commits default in complying with any of the terms and conditions of Contract anddoes not remedy it or take effective steps to remedy it within 7 days after a notice inwriting is given to him in that behalf by the Purchase Department; or
- c. Fails to complete the works or items of work on or before the date(s) of completion, and does not complete them within the period specified in a notice given in writing in that behalf by the Purchase Department; or
- d. Violates any of the terms and conditions stipulated in this agreement
- e. Being a company, passes a resolution or the Court makes an order for liquidation of its affairs, or a receiver or manager on behalf of the debenture holders is appointed orcircumstances shall arise which entitle the Court or debenture holders to appoint areceiver or manager; or

21. Liability for Damage, Defects or Imperfections and Rectification thereof:

If the Contractor / Supplier or his workmen or employees shall injure or destroy anypart of the building in which they may be working or any building, road, fence, etc.contiguous to the premises on which the work or any part of it is being executed, or ifany damage shall happen to the work while in progress the Contractor / Supplier shallupon receipt of a notice in writing in that behalf make the same good at his ownexpense. If it shall appear to the Director, NIEPMD or his Representative at any time prior to the expiration of Defects Liability Period, that any work has been executedwith unsound, imperfect or unskilled workmanship or that any material, article orequipment provided by the Contractor / Supplier are of sub -standard quality, shall,upon receipt of a notice in writing in that behalf from the Officer- in-charge, forthwithrectify or

remove and replace the same so specified in whole or in part, as the casemay require or as the case may be, and / or remove the materials or articles at his ownexpense, notwithstanding that same may have been inadvertently passed, certified andpaid for and in the event of his notice aforesaid, the Officer- in-charge may rectify orremove and replace the work and / or remove and replace with others the materials orarticles or equipment complained of, as the case may be, by other means at the riskand expense of the Contractor / Supplier.

In case the Contractor / Supplier fails to comply with the requirements of thiscondition, the Director, NIEPMDshall have the right to get the work done by othermeans at the cost of the Contractor / Supplier. Before taking such action, however, theDirector, NIEPMDshall give three days notice in writing to the Contractor / Supplier.

22. VALUATION AND PAYMENT:

- 22.1 After carrying out the entire work successfully by the Contractor / Supplier ,
- the

Contractor / Supplier /supplier shall submit the bill to the Institute for the payment. The Director, NIEPMDshall accept as otherwise stated ascertain and determine thevalue of work done in accordance with the contract agreement therewith

22.2 No escalation will be paid even in extended period, if any.

22.3 All statutory deductions as applicable like TDS, sales tax/VAT shall be made from thedue payment of the Contractor / Supplier.

23. Income Tax/WCT/VAT

- 23.1 Income tax including surcharge if any, at the prevailing rate shall be deducted from the Contractor / Supplier 's bills as per the provision of Income Tax Act.
- 23.2 The Contractor / Supplier shall ascertain from the concerned commercial taxdepartment regarding the applicability of Works Contract Tax / VAT/TIN. Necessarydeductions will be made from the Contractor / Supplier 's bill as applicable.

24. ARBITRATION AND

LAWS Arbitration:

Except where otherwise provided for in the contract all questions and disputes relatingto the meaning of the specifications, designs, and instructions herein beforementioned and as to the quality of workmanship or materials used onto work or as toany other question, claim right matter or thing whatsoever in any way arising out of orrelating to the contract, designs, specifications, estimates, instructions, orders and these conditions or otherwise concerning the works, or the execution or failure toexecute the same whether arising during the progress of the work or after thecompletion or abandonment thereof shall be referred to the sole arbitration of theDirector of the NIEPMD, and if the
