2. Bidder must submit a certificate that OH aid & appliances supplied by him **must have ISI certification** and he is able to supply the material on credit of 30 days after clear receipt of materials.
3. The bidder should have an annual minimum turnover of **Rs.1 crore**. Proof of certificate for turnover is required to be submitted with the tender (**CA attested certificate or copy of the balance sheet with profit and loss account should be enclosed with technical bid.**)
4. The applying firm must be registered with the Sales Tax / Value Added Tax and the supporting proof for the same is to be attached.
5. Bidders should provide brief profile of their work experience for the last three years along with the relevant samples of the similar work done earlier.
6. The tender received through fax / e-mail or received late due to postal delay etc. will not be accepted. The parties have to ensure the receipt of bids well in time.

7. The successful bidder will be required to execute a performance security of ten percent of the value of the contract in form of fixed Deposit with bank with lien made until the contract is over or one year, whichever is later.

9. The materials should be delivered at Chennai and to other locations in Tamilnadu & India. The transportation charges in the cheapest available mode to other locations in India and in Tamilnadu will be paid by NIEPMD.

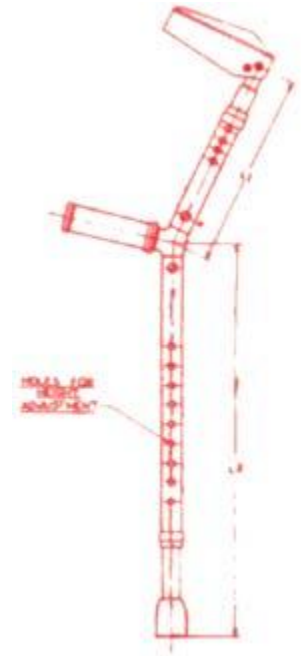

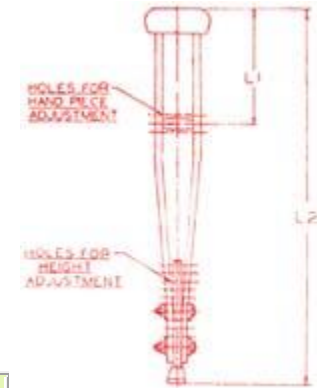
