Also the demurrage charges will be applied to the delayed supply @ 0.5% per week. If the delay is for 01 or 02 days, complete 01 week demurrage charges will apply.
- 14. The NIEPMD reserves the right to accept or reject any tender without assigning any reason thereof.
- 15. Payments will be made only after the medicines are received in full and good condition to be certified by the Indentor and after completion of satisfactorily supply. There shall not be any advance payment and no such request shall be entertained.
- 16. Any attempts of negotiation / campaign, direct or indirect, on the part of a tenderer with the authority to whom he has submitted the Tender or the authority who is competent finally to accept, shall render such Tender liable to be excluded from consideration.

IMPORTANT INSTRUCTION TO BIDDERS

(Annexure to Agreement)

- 1. The NIEPMD, Chennai intends to enter into an Annual Rate Contract for procurement of Medicine for its clients for one years extendable to two more years on satisfactory performance basis. These items will be purchased as per requirement from time to time.
- 2. In case any firm is already providing the medicine to any other Government Hospital and reputed private Hospitals details thereof may also be furnished along with the Tender.
- 3. The following terms and conditions may be kept in view while applying for tender:-
- a) The firm should be in a position to supply medicine on short notice as and when needed (say within 24 hrs).
- b) All expenses will be borne by the firm for sending the medicine to NIEPMD, Chennai premises.
- c) The Medicine should be delivered to the NIEPMD, Chennai premises as per the term of purchase order or in case of emergency within 24 hrs. of the receipt of the orders / email or phone communication. In case the firm fails to supply the medicines as per requisition, the firm will give "Not Available Certificate" within 24 hrs. and the Institute will be at liberty to make spot purchases from any alternative source and the difference in cost will be recoverable from the firm.
- d) The rates discount/quoted/offered shall remain fixed during rate contract period and no request for any increase in the rates shall be entertained.
- e) The owner/firm should be available on his own direct telephone (office as well as residence) and also on mobile phone so they may be contacted immediately in emergent cases. The Mobile Number may also be provided.
- f) Up to date drug license as issued by concerned State Drug Authority.
- g) Medicines shall be supplied from manufactures holding up to date Good manufacturing Practices (GMP) certificate issued by the appropriate Licensing Authority and WHO, ISO certified and other relevant quality certifications. A copy of the certificate shall be produced by supplier within 2(Two) weeks whenever demanded by NIEPMD, Chennai.
