  - Extension and cultural activities need to be discussed by all the departments of the NIEPMD, NAAC.
  - Information relating to students including admission data base of each department, student ratio, Gender ratio, Percentage of OBC, SC,ST, minority students, student placement and higher studies need to be communicated to IQAC by the Heads and Coordinators of each department.
- Registrar is requested to issue circular to all concerned for communicating information to IQAC.
- Collaboration with various universities and NGO'S discussed for with the plan of action.
- Faculty encouraged to take Research proposal at institute level, Ministry level and Intra department level.
- The NIEPMD should take immediate steps to fill up the teachers/faculty/professionals as per need to provide quality education.
- The meeting concluded with a formal vote of thanks to Chair and to all the member for their kind presence, valued suggestions and deliberation.
